- 2. The TRUFORMA Instrument requires cartridges to function. You can only use Zomedica cartridges with the TRUFORMA instrument. You may purchase cartridges for use with the TRUFORMA instrument by placing a purchase order with Pioneer. Pricing for cartridges is as follows:

- 6. You may elect to cancel this agreement at any time with thirty (30) days' prior written notice by contacting Pioneer.
- 7. Pioneer may remove the instrument if you request termination of the Agreement If you are unable or unwilling to return the instrument at the end of the term of this Agreement, you will be charged a fee of £5,995 for the instrument.
- 8. Zomedica will update and service the TRUFORMA instrument during the term of this Agreement, including substituting or replacing the instrument as Zomedica deems necessary. Zomedica and Pioneer reserve the right to access the TRUFORMA instrument for the purpose of providing routine maintenance and support.
- 9. Customer gives Zomedica a non-exclusive, global, transferable license to use data collected by the TRUFORMA instrument. Zomedica may publish data collected, however, Zomedica agrees that it will anonymise any information included in the images retrieved prior to any publication. Notwithstanding the foregoing, each party is responsible for complying with all applicable data privacy laws including obtaining customer consent if required.
- 10. The TRUFORMA instrument remains the property of Zomedica. All right, title and interest to the instrument remains with Zomedica at all times. At no time will you, nor will you permit any third person to, disassemble, reverse-engineer, reverse compile, or reverse assemble the instrument, perform any analysis on the instrument, or any of its components or the cartridges, or otherwise attempt to gain access to or determine how the instrument functions.
- 11. Pioneer and Zomedica's standard customer terms and conditions which can be found on Pioneer's and Zomedica's websites apply to this agreement.
