A sample of SKU080A – PROCESSUS Pre-Clean Instrument Spray 750 mL, Batch 232545 underwent evaluation to assess suitability for a shelf-life extension.

Sample was subjected to accelerated ageing at 54°C for 2 weeks (to represent 2 years ambient stability).

Ageing started on 13th June 2025 and completed on 27th June 2025.


The sample was then put through Physico-chemical testing as well as microbial challenge testing. The product met all acceptance criteria during Physico chemical testing, demonstrating continued stability, appearance, odour, pH, and functional performance consistent with specification. No degradation or adverse changes were observed.

Challenge testing at MCS laboratories was successful (reference code SFW005/40A), indicating that the preservation effectiveness of the product was not affected.

Based on these results, the shelf life of Batch 232545 , and expiry date is extended:
